

# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.travelwithgreatcompany.com and Travel With Great Company and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Travel With Great Company include www.travelwithgreatcompany.com, Travel With Great Company and Gifted Travel Network. The Travel With Great Company website is a travel information and planning site. By using the Travel With Great Company website, you consent to the data practices described in this statement.

The customer agrees that by the use of Travel With Great Company services for the booking of travel, certain personal information may be conveyed to third parties relevant and necessary to the transportation and accommodation of your travel. Travel With Great Company shall not be responsible for the further use of said information by third parties by the customer.

### **Collection of your Personal Information**

## Limitations on accuracy and updating of your information

Travel With Great Company may update the personal information that we have on file for you. Travel With Great Company shall not bear responsibility for any personal information that is inaccurate. You agree to supply updated personal information to Travel With Great Company as necessary for booking procedures. Travel With Great Company takes reasonable steps to protect
